### Competition Rules / Details

#### Individual Patterns

1. All competitors must arrive at the tournament venue in a timely manner and report to the officiating Black Belt.
2. Fully completed tournament entry forms must be submitted by all competitors before participation.
3. All competitors must wear a complete, clean and pressed uniform. Please remove all jewelry and trim all nails.
4. Competitors may choose any pattern including four step directional punch and four step directional block up to and including their current rank pattern.
5. The process of elimination shall be either the pyramid or round robin depending on the number of competitors in each category/group.
6. Proper Courtesy and Respect is to be shown at all times. Competitors must at all times bow to the judges and each other at the beginning and end of each match/round.
7. All Judges decisions will be final.

#### Team Patterns

1. Participation in the main patterns category is required for eligibility in the team category.
2. Teams shall consist of 5 students with no more than 2 black belts students per team.
3. Team applications must be submitted by January 30, 2010.
4. Teams may select any ITF pattern; additional points will be awarded for higher rank patterns.
5. Points will be awarded for team work, choreography, technical content, power, balance, breath control, and rhythm.
